But where the attorney has entered into a CPA with the client, the client must not be permitted to switch attorneys in mid-stream. Rule 4.2 of the Rules of Professional Conduct state: A lawyer who has formerly represented a client in a matter shall not thereafter: * * * * * (2) use information relating to the representation to the disadvantage of the former client except as Rule 1.6 would permit with respect to a client or when the information has become generally known; or (3) reveal information relating to the representation except as Rule 1.6 would permit with respect to a client. The Louisiana State Bar Association Professional Responsibility Tribunal has broad authority to investigate unprofessional conduct and to take appropriate action against members of the bar when professional misconduct is discovered. After reviewing the evidence presented, we find that respondent violated rules 5.3 and 4.1 of the Rules of Professional Conduct, Rule 1.8(a)(2), and Rule 1.4(a) of the Rules of Professional Conduct. Respondent does not assert any mitigating factor, nor do we find any. The record shows that respondent received letters from Ms. Saucier threatening to sue him for malpractice. Respondent did not threaten to sue Mr. Hamiter for malpractice, but rather he withdrew as Mr. Hamiter's attorney before threats were made. We find that respondent's actions constituted conduct prejudicial to the administration of justice and demonstrates that respondent failed to cooperate with the disciplinary process in violation of Rule 8.4(d) of the Rules of Professional Conduct. We find that respondent violated the following provisions of the Rules of Professional Conduct: rule 5.3, *245 rule 4.1, rule 1.8(a)(2), rule 1.4(a). DECREE Upon review of the record, it is ordered that respondent, Brandy Jo Toliver, be suspended from the practice of law for a period of ninety days.
